
其他意見:

- ▶ 上調股票交易印花稅稅率

其他意見:

- dividend tax on listed companies
- Tax payer should enjoy the same tax deduction for dependent parents no matter they live with them or not. In the situation of HK, not many people have the space to live with parents after marriage.
- 改革累進稅率 higher income group (both individual and company) should pay more tax, not cap at a flat rate
- tax incentives for R&D, vaccine production, shipping and aircraft leasing sectors
- Commercial building allowance is granted to companies holding property for the purpose of attracting investment funds. There are too much liquid fund in the market under this low interest rate environment and resulting to ever increasing property value. Property holding is capital nature and is not subject to capital gain tax. Therefore it's fair to cancel the commercial building allowance given to property (especially for residential property) and also adding back those CBA previously claimed.
